### 1 Minutes

- Today is opening day for Paxton residents' mixed media art show at COA. Six residents are showing, voting is available for Best in Show. Show will be up for three months.

#### 3.Director's Report

- 1. Financial report was presented. Report on file at the Director's office.
- 2. Van transportation is transitioning to a SCM Elder Services/WRTA blue van effective April 1. COA van will be available through June 30<sup>th</sup> for appointments already booked. Two public meetings are scheduled to discuss transportation changes: March 19, 10:30 am for Paxton Hills residents and March 20, 10:30 am at COA.
- 3. Building update: New policy: Anyone who uses COA building will have to pick up keys at dispatch, sign for them, and return them after meeting.
- 4. ADA grant: needs to be completed by June 30. Three bids need to go out, will choose by end of March. Updates have to go before the Historical Commission. Anita would like a camera at the entrance.
- 5. Miscellaneous: Outreach busy as usual; food pantry is well supplied; fuel assistance is available. St. Patrick's Day is filling up; a panel will discuss downsizing, selling, and relocating. Café today recognizes artists in art show. Pen Pal program is going well. Will have a meet and greet for participants June 7.
