• **(PB)** Put on the next agenda to give Mrs. D'Andrea a chance to come in and speak, and also to have time to check out the street.

9 Elm Street

• **(CR)** This resident is looking to hook up to the Worcester sewer system. We have done this with other propertied in town, and the onus is completely on the owner of the property.

- Motion (PB) seconded (JP) to enter into agreements with the City of
 Worcester, the Upper Blackstone Water Pollution Abetment District and the
 owners of 9 Elm Street for the conveyance of sewage from that property
 through the Worcester sewage system for treatment at the Upper Blackstone
 facility with all costs to be paid by the property owners, including and legal
 cost incurred by the Town of Paxton. Unanimous, all in favor.
- Mr. Economos, current owner of 9 Elm St, inquired if the permit fee would be paid to Worcester and Paton?
- (CR) No, will send the bills directly to you.
- Mr. Economos also stated that there is no sign for Elm Street.
- (CR) If there was one DPW will replace it.

Annual Appointments

- Motion (PB) seconded (JP) to appoint the list of individuals presented with the terms that are listed. Unanimous, all in favor.

American Legion sign request

- Motion (PB) seconded (JP) to approve sign request with the understanding that for the July 5th event the sign comes down by noon on July 3rd. Unanimous, all in favor.

• (JP) Our next meeting is scheduled for June 30, 2012 and then we will see where the state budget and school are at. I would also like to get Jack's input.

Bay State sign request

 Motion (PB) seconded (JP) to approve sign request from Bay State Equine Rescue 5K road race on July 13. Sign can go up from July 7th to July 14th. Unanimous, all in favor.

Paxton Center School turtle crossing sign request

- (JP) Through a Cultural Council grant they would like to put up turtle crossing signs in designated areas of Town.
- (JP) Some of these areas are residential. Do we know what the signs will look like?
- (CR) DPW is helping to provide the signs.
- Motion (PB) seconded (JP) to approve the turtle crossing signs with the assistance of the DPW in order to establish exactly where the sign will be placed. Unanimous, all in favor.

Letter of intent from the Town of Spencer

- (JP) With the budget issues that Spencer is facing they are looking to combine with other towns to solicit more state funding.
- **(PB)** The difficulties that the two towns are having are different. We need to do what is best for Paxton which differs from what Spencer needs. To have a discussion with other communities may be beneficial but I'm unsure if we should jump right in.

- (JP) Our struggles are different from Spencer's.
- **(PB)** A symposium was mentioned, and I am willing to attend and start the discussion process.
- (JP) Carol will send a letter to Spencer asking them to include us on an invites to upcoming meetings.
