Notice of Intent:

281 West St.

There is a revised plan presented by Scott Jordan of Eco-Tec and Peter Engle of McClure Engineering. The revised plan shows a driveway that crosses a stream with a box culvert over the stream. There will be a retaining wall along the driveway. There is a slope of 15° that will be vegetated with bonded fiber matrix hydroseeding. A 1/8 inch thick wire backed barrier and silt fencing will be in place for erosion control. The Board of Health has accepted the septic plan. 1800 ft.² of vegetated wetland will be replicated. There will be 4 separate areas of replication to total 3700 ft.². DEP had no technical comments. The replication will include forested wetland plants in 2 areas. Two other areas will be replicated with wet meadow plants. BF asked if markers would be needed. MV opined that the wetland is obvious so he did not think markers were needed. HR asked when the replication will be done. EcoTec reports that replication will be done in spring of 2024 so the plants can take root. DS moved to close the hearing and JR seconded. All in favor none opposed.

JR asked if the box culvert is 3 sided and Mr. Engle responded that it is. A standard Paxton order of conditions will be issued.
