Request for Certificate of Compliance for Lot 3 Suomi Street (Map 13, Parcel 5 portion,)
DEP File #257-0280, 9/12/2013 (Now 131 Suomi Street) Rebecca Couture and Mark
Letourneau, current owners, present to request the Certificate of Compliance. The Commission
discussed that the house was built in a different location than what was approved. Now being
closer to the wetland resource area, the Commission would like to see a permanent bound
between the lawn and resource areas along the 25-foot buffer. The owners agreed and requested
to plant a row of shrubs, planted 3' to 4' on center and to cease mowing the 25 foot buffer to the
wetlands. The Commission thanked them for their time and cooperation and asked them to call
for an inspection once the shrubs were planted. Mia will visit the site to delineate the wetland
resource areas. Another site inspection shall occur in October to review the plantings and the
Commission will review the issuance of the Certificate of Compliance at that time.

Forest Cutting Plan received for Suomi Street. The Commission and staff reviewed the plan and determined the land was located behind 78 Suomi Street. Much of the area was proposed clear cut and minimal erosion controls were installed. The Commission asked MM to email the state forester their concern that this was not long-term forest management, but pre-development site clearing and should be permitted as such.

JR motioned and DD seconded and JR, LA, DD, BF and MV voted by roll call to close the meeting. The meeting was adjourned at 9:01PM.
