# **Public Hearings:**

#### Notice of Intent for 3 Olivia Knoll (aka Lot 1) Map 11 Lot 16G DEP File #257-317

Presented by Scott Jordan of EcoTec and by Robert Clark for construction of a single-family home with associated grading, driveway, retaining wall, utilities, septic, cultec recharge chambers, landscaping and associated site work within the 100-foot buffer of wetland resource areas. Mr. Clark stated the water easement shown on the plan has been extinguished. The Commission discussed the proposed house location within the 15' and 30' restrictive buffers from the recently passed Paxton Wetlands Bylaw and decided this project is exempt from the new bylaw because the house lots were designed and approved as part of a subdivision plan that was approved in 2011. Due to the water easement no longer restricting the site, the Commission requested the proposed house location is moved further from the wetland resource areas, if possible. LA requested public comment. None given.

Mr. Jordan requested to continue the hearing to July 8 to modify the plans. JR made a motion, DD seconded and all voted in favor of continuing the hearing to July 8.

## Notice of Intent for 4 Olivia Knoll (aka Lot 5) Map 11 Lot 16K DEP File #257-318

Presented by Scott Jordan of EcoTec and by Robert Clark for construction of a single-family home with associated septic system, driveway, retaining wall, grading, landscaping and associated site work within the 100-foot buffer of wetland resource areas. Mr. Jordan confirmed the retaining wall was located along the 30' buffer. The Commission discussed the project and determined the wall would serve as a suitable barrier to the resource areas. LA requested public comment. None given. JR motioned, MV seconded and all voted in favor of closing the hearing.

JR motioned, MV seconded and all voted in favor of issuing an Order of Conditions with the standard conditions and PCC special conditions for septic systems.

## Notice of Intent for 5 Olivia Knoll (aka Lot 2) Map 11 Lot 16H DEP File #257-319

Presented by Scott Jordan of EcoTec and by Robert Clark for construction of a single-family home, grading, utilities and associated site work within the 100-foot buffer of wetland resource areas. Mr. Clark stated the proposed house location may move 17 feet closer the street and further from the wetland

resource areas as requested by the homeowner to create a larger backyard area. LA requested public comment. None given.

JR motioned, DD seconded and all voted in favor of closing the hearing.

MV motioned, JR seconded and all voted in favor of issuing an Order of Conditions with the standard conditions and PCC special conditions for septic systems, as well as the conditions that 3 "Do Not Disturb — Wetland Resource Area" signs are installed no closer than 15 feet from the wetland resource areas. One sign is to be at the rear of the property along the edge of the lawn, two signs are to be placed along the western edge of the property. Mounted on trees or on posts.

**Draft Wetlands Regulations Discussion** – Solicitation of public comment on the proposed regulations that support the Paxton Wetlands Bylaw. No public comment offered. JR motioned, MV seconded and all voted in favor of adopting the wetland regulations as written except for the fees as they are yet to be determined.
