## Certificate of Compliance for Lot 1 Davis Hill Road DEP File No. 257-0267.

As-built received at meeting. Certificate for Compliance (original signed) given to Kim Ames for recording at the Registry of Deeds.

# Certificate of Compliance for 153 Suomi Street DEP File No. 257-0292.

JR motioned and MV seconded to issue the Certificate of Compliance once TL visits the site to confirm the outlet pipe for the stormwater basin has been moved.

# Certificate of Compliance for 50 Sunset Lane DEP File No. 257-0263

This Certificate of Compliance was issued in November 2011, but the original is missing from the file and it was never recorded. The Commission discussed and the certificate was re-issued and re-signed with a note that this is a re-issue of the vote from the November 2011 meeting.

### **Informal Discussion:**

#### **Paxton Stormwater Permit**

TL, LA and MM made a list or requirements, as well as a list of questions for the permit. A meeting has been scheduled on January 4<sup>th</sup> at noon with Carol Riches and Mike Putnam to review the list of questions. Once it is confirmed what has been completed and what is required, the list of requirements will be matched to data from the Central MA Regional Stormwater Coalition on time and money required to complete the actions.

### **Budget:**

The Commission discussed the budget and decided to request level funding for 2019. JR motioned and MV seconded to approve the FY19 budget with level funding request. MM shall submit the budget request via email.

## **MACC Dues**

The Commission discussed and decided to pay the dues for the MA Association of Conservation Commissioners of \$417, plus additional fees of \$120, for a total of \$537 for 2018. They also decided to purchase the online handbook, which is listed for \$15 on the MACC website. MM to process these payments to MACC and request a new login for the handbook.

# **Paxton Wetland Bylaw**

MM submitted proposed changes to the wording to address the MA Attorney General's comments. The Commission discussed and asked for paragraphs 2 and 3 to be switched in the appeal section. It was also discussed and decided to change the fine to \$100 per violation. The Commission requested a formal review from a lawyer. MM to check with Town Counsel and seek quotes for legal review.

### **Merry Lane**

A resident from Merry Lane contacted the Commission to request a written report of a site visit that occurred circa 2014. MM searched the minutes and both paper and digital files, as well as soliciting input from the commissioners via email. Chris Keenan remembers visiting the site and discussing plantings within the yard and the work was determined to not need a permit at the time. A written report can not be created as the location of the resource areas and plantings can not be determined under the snow cover.

**Site Visits:** due to the Merry Lane site visit, it was determined that future site visits, even if no permit is required, shall be documented in the minutes. The Commission also does not provide written reports that permits are not required. If written determination is required to determine that work is not jurisdictional, then the landowner shall submit a Request for Determination of Applicability to the Commission as a formal application.

**65 Suomi Street Forest Cutting Plan** received from the land owner. The Commission reviewed and expressed concern that the work may be completed to create a lawn adjacent to a resource area without a permit. MM shall contact Kate Marquis, state forester, to discuss the site.
