Request for Certificate of Compliance: 7 Indian Hill Road Site visit was completed by TL and MM, rear of the property is vegetated, bushes planted as requested, TL approved use of hydroseed, forested wetland along the side of property is fully stable and vegetated, rocks removed. MV motioned and TL seconded to issue the Certificate of Compliance.

Informal Discussion:

Proposed Draft Regulation – The comments from the Attorney General's office were reviewed. The two issues to be addressed are: 1.) The wording of the fee for fines and 2.) more details on the appeal processes. The Commission discussed and asked MM to draft alternate wording for each section to further clarify fees and appeals. MM was also asked to contact the Board of Selectman and the Zoning Board of Appeals to discuss their possible roles as appeal board. The Commission asked if the bylaw could be placed into effect without those sections in question.

Pleasant Street, Bob Clark/Clark & Mott's driveway construction (DEP File #247-0308) The Commission discussed the site: no wetland restoration report has yet been received and no restoration work has been observed on the property. The Commission asked MM to contact Mr. Clark to state that they are expecting a report on the restoration by September 30 and a discussion at the October 12 meeting, and to follow up with a certified letter.


