TOWN CLERK'S REPORT.

WARRANT AND ACTION THEREON AT ANNUAL MEETING, MARCH 2ND, 1914.

Article 1. To choose a moderator, by ballot, to preside at said meeting.

Chose Henry H. Pike.

Article 2. To hear the reports of the town officers and committees and act thereon.

Voted to accept and adopt the reports of the Selectmen, Collector of Taxes, Town Treasurer, Overseers of the Poor, Trustees of the Public Library, and Assessors.

Article 3. To bring in and deposit their ballots for Town Clerk, three Selectmen, three Overseers of the Poor, Town Treasurer, Collector of Taxes, Auditor, two Constables, three members of the Board of Health, and Superintendent of Streets, each for a term of one year; one Assessor for three years, and three Library Trustees, two for a term of three years and one for a term of two years to fill vacancy; also one member of the School Committee, for three years. All the above to be voted for on one ballot; also upon the same ballot to vote "Yes" or "No" on the question:—"Shall license be granted for the sale of intoxicating liquors in this town?"

Also upon the same ballot to vote "Yes" or "No" on the question, "Shall chapter 807 of the acts of nineteen hundred and thirteen, being an act to provide for compensating laborers, workmen and mechanics for injuries sustained in public employment, and

to exempt from legal liability counties and municipal corporations which pay such compensation, be accepted by the inhabitants of this town?"

Also upon the same ballot to vote "Yes" or "No" upon the question, "Shall this town accept the provisions of section forty-two of chapter five hundred and fourteen of the acts of the year nineteen hundred and nine, as affected by chapter four hundred and eleven, which provides that eight hours shall constitute a day's work for city or town employees?"

Also to choose all other necessary town officers for the year ensuing.

The polls will be opened at 11 o'clock A. M. and closed at 3 o'clock P. M.

The Moderator declared the polls open at eleven o'clock A. M. The whole number of ballots cast, sixty-three (63).

The vote on the License Question was as follows:

The officers elected will be found on the first two pages of this report.

Article 4. To appropriate such sums of money as may be deemed necessary for the support of the town's poor, repair of highways and bridges, support of public schools, and transportation of scholars, breaking out roads, and for fire purposes and for contingent expenses for the ensuing year.

Voted to raise and appropriate the sum of three hundred and fifty dollars (\$350) and the income of the D. R. Boynton Fund for the support of the town's poor.

Voted to raise and appropriate the sum of six hundred dollars (\$600) for repairs of highways and bridges.

Voted to raise and appropriate the sum of fourteen hundred dollars (\$1400) for support of public schools and transportation of pupils.

Voted to raise and appropriate the sum of four hundred dollars (\$400) for breaking out roads.

Voted to raise and appropriate the sum of twenty-five dollars (\$25) for fire purposes.

Voted to raise and appropriate the sum of ten hundred and fifty dollars (\$1050) for contingent expenses.

Article 5. To see if the town will grant and appropriate a sum of money for Memorial Day, and for the relief of indigent and disabled soldiers.

Voted to raise and appropriate the sum of ten dollars (\$10) for Memorial Day.

Voted to raise and appropriate the sum of two hundred and sixteen dollars (\$216) for relief of indigent soldiers.

Article 6. To see what disposition the town will make of its Dog Fund.

Voted that the Dog Fund be appropriated for the Free Public Library.

Article 7. To see if the town will vote to raise and appropriate a sum of money to pay the balance due on the Electric Light Plant and for care and maintenance of the same.

Voted to raise and appropriate the sum of seven hundred and fifty dollars (\$750) to pay balance due on the Electric Light Plant and for the care and maintenance of the same.

Article 8. To see if the town will grant a sum of money with which to pay a proper charge of an Insurance Company for acting

as surety on Official Bonds required by town officers and authorize the Selectmen to approve the same or act in any way thereon.

Voted to raise and appropriate the sum of fifteen dollars (\$15) to pay for surety on official bonds.

Article 9. To see if the town will vote a discount on taxes paid before a given date and fix a time when interest shall be charged and taxes made payable, and likewise fix the compensation to be paid the Collector for the ensuing year or take any action in relation thereto.

Voted not to discount taxes and that taxes be made payable and interest charged same as last year and that the compensation paid the Collector be the same as last year.

Article 10. To see if the town will authorize the Town Treasurer, by and with the approval of the Selectmen, to borrow money from time to time in anticipation of revenue of the present municipal year beginning Feb. 1st, 1914, to an amount not exceeding in the aggregate, three thousand dollars (\$3,000) and to issue a note or notes therefor payable within one year.

Voted that the Town Treasurer, with the approval of the Selectmen, be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the municipal year beginning Feb. 1st, 1914, to an amount not exceeding in the aggregate three thousand dollars, (\$3,000), and to issue a note or notes therefor payable in one year, any debt or debts incurred under this vote to be paid from the revenue of said municipal year.

Article 11. To see if the town will vote to accept the list of Jurors as prepared and posted by the Selectmen.

Voted that the town accept the list of Jurors.

Article 12. To see if the town will vote to raise a sum of ten dollars (\$10) and appropriate as much of it as may be necessary to carry out the provisions of Chapter 502, Acts of 1906, relating to the appointment of school physicians.

Voted that the town raise the sum of ten dollars (\$10) for said purpose.

Article 13. To see if the town will fix the compensation for labor on the highways the ensuing year.

Voted that the compensation for labor on the highways for the ensuing year be as follows:

Twenty cents (20c) per hour per man. Thirty cents (30c) per hour per pair of horses to July 1st, 1914; after July 1st, twenty-five (25c) per hour per pair of horses.

Article 14. To see what action the town will take regarding the care and rental of the town hall, and also the care of the town clock the ensuing year.

Voted that the care and rental of the town hall, and also the care of the town clock be left with the Selectmen.

Article 15. To see if the town will grant a sum of money to be used to suppress the gypsy and brown tail moths in this town.

Voted to raise and appropriate the sum of twenty-five dollars (\$25) for the suppression of the gypsy and brown tail moths.

Article 16. To see if the town will grant a sum of money to be expended in the care and improvement of the Common or act in any way thereon.

Voted to raise and appropriate the sum of fifteen dollars (\$15) for the care of the Common.

Article 17. To see if the town will grant a sum of money to be expended by the Tree Warden, the ensuing year.

Voted to raise and appropriate the sum of ten dollars (\$10) to be expended by the Tree Warden.

Article 18. To see if the town will vote to raise and appropriate a sum of money to pay the balance due on repairs on Barre Road from terminus of State Road to Rutland line.

Voted the sum of five hundred dollars (\$500) to pay balance due on repairs on Barre Road be paid from the surplus in the hands of the Town Treasurer.

Article 19. To see if the town will vote authorizing the painting of the exterior of the School House, grant and appropriate money or take any action relating to the same.

Voted the sum of two hundred dollars (\$200) be raised and appropriated for the painting of the exterior of the school-house and that the Selectmen call for bids for the job and let it out as they think best.

Article 20. To see if the town will petition the Director of the Bureau of Statistics for an audit of its accounts in accordance with the provisions of Chapter 598, Acts of 1910, and amendments thereof.

Voted to pass over the article.

Article 21. To see if the town will accept the sum of fifty dollars (\$50) as left by will of George W. Cowden, and also fifty dollars (\$50) provided by the Streeter Heirs, the income to be used for the care of the Stephen Stréeter lot in the Paxton Cemetery.

Voted that the article be accepted.

Article 22. To see if the town will vote to develop a portion of the new cemetery, appropriate a sum of money for that purpose and appoint a committee to expend the same or act in any way thereon.

Voted to raise and appropriate the sum of two hundred dollars (\$200) for development of the new cemetery, and that the Cemetery Committee be authorized to expend the same.

Article 23. To see if the town will accept the provisions of Chapter 361 of the Acts and Resolves of 1912, entitled "An act to authorize the Town of Paxton to supply itself with water" or act in any way thereon.

Voted to accept the article.

Article 24. To see if the town will grant a sum of money for a new watering trough near the "Streeter Place" so-called.

Voted that the sum of twenty-five dollars (\$25) be raised and appropriated for a cement watering trough near the "Street-er Place" so-called, and that said sum be expended by the Selectmen.

Article 25. To see if the town will vote to pay the balance due the Road Commissioner or act in any way thereon.

Voted to lay article 25 on the table to be taken up later.

Voted that article 25 be taken from the table. Voted to pay balance due the Superintendent of Streets.

Article 26. To see if the town will vote to discontinue the road leading from the Barre road near the residence of Frank A. Pierce, over "Christian Hill," so-called, to the Barre road opposite the road leading to the "Howe Place."

Voted to pass over article. Voted to reconsider same. Voted to discontinue road leading over "Christian Hill," so-called.

Article 27. To see what action the town will take in regard to payment of outstanding demand notes as provided under Section 1, Chapter 634, Acts of 1913.

Voted that the demand notes be changed to serial notes and that five hundred dollars (\$500) and the interest on the whole be paid yearly until all is paid.

Article 28. To see if the town will vote to raise and appropriate a sum of money to pay for the transportation of High School pupils.

Voted to raise and appropriate the sum of six hundred and twenty-five dollars (\$625) for the transportation of High School pupils.

Article 29. To see if the town will vote to raise and appropriate a sum of money to pay for insurance against damage of any kind in connection with the Electric Light Plant.

Voted to raise and appropriate the sum of one hundred and fifty dollars (\$150) to pay for insurance against damage of any kind in connection with the Electric Light Plant.

Article 30. To see if the town will vote to appoint a committee to make arrangements for the celebration of the 150th anniversary of the incorporation of the town in 1915.

Voted that the Selectmen be a committee to make arrangements for the 150th celebration of the town and that they be authorized to petition the legislature for privilege of raising money for the same.

Article 31. To see if the town will vote to raise the pay of the Town Treasurer or act in any way thereon.

Voted to raise the salary of the Town Treasurer twenty dollars (\$20) making said salary sixty dollars (\$60).

Article 32. To see if the town will vote to appropriate the sum of one hundred and fifty dollars (\$150) for the wiring of the town hall as authorized at special town meeting. *

Voted to pass over the article.

Voted to dissolve the meeting.

SPECIAL TOWN MEETING HELD ON JULY 6TH, 1914.

Article 1. To choose a moderator to preside at said meeting.

Chose Henry H. Pike, moderator.

Article 2. To see if the town will vote to appoint a committee or act in any way regarding the improvement of the horse sheds.

Voted to choose a committee of three to investigate and report. Chose Fred L. Durgin, Cutler L. Crouch, Clarence A. Rossier.

Article 3. To see if the town under certain conditions will vote to extend the electric light system to the residence of Mrs. Helen M. Green and appropriate a sum of money for the same.

Voted to authorize the extension of the electric light system to the residence of Mrs. Helen M. Green and that the sum of one hundred and fifty dollars (\$150) to be taken from the surplus in the hands of the Town Treasurer for said purpose.

Article 4. To see if the town will elect a Committee consisting of three members to have charge of the electric light plant, one member for one year, one for two years, and for one three years and every year thereafter elect one for three years, or act in any way thereon.

Voted to elect by ballot a Municipal Light Board of three members one for a term of one year, one for a term of two years, and one for a term of three years, whose terms of office shall expire at the Annual Town Meetings in 1915-1916 and 1917 respectively. And at each Annual Town Meeting hereafter to elect one member of said Board for a term of three years.

Chose Fred L. Durgin, 3 yrs.	Term expires 1917.
Arthur W. Dwyer, 2 yrs.	" " 1916.
Charles M. Bullard, 1 yr.	" " 1915.

Article 5. To see if the town will appropriate a sum of money and instruct the Selectmen to get a survey of a portion of the Howe Place and repair fence on same or act in any way thereon.

Voted to appropriate the sum of fifty dollars (\$50) and to instruct the Selectmen to establish the line between the Howe Farm and land owned by G. A. Rossier, and to build a fence on the half of the line belonging to the town.

Voted to dissolve the meeting.

Report of Cemetery Trustees.

The land which the town purchased in 1913 for a new Cemetery was formerly owned by a family of Moores who were early settlers of the Town of Rutland from which the north part of this town was taken.

Mrs. Roxa Howard Bush, who is a descendant of this family, requested to have it named "Mooreland Cemetery," which we thought a very proper thing to do and voted to give it that name. At the last Annual Town meeting the town voted two hundred dollars (\$200) with which to develop this cemetery.

We had it surveyed by Mr. E. D. Woods of Worcester, and plans drawn. One large plan is in the Record Building. Mr. Woods' bill was seventy-three dollars and three cents (\$73.03). Stone bounds have been set at the corners of the land and avenues one quarter or about four acres have been plowed, smoothed off and seeded at a cost of eighty dollars and seventy cents (\$80.70). Received for standing grass, twelve dollars, which leaves forty-one dollars and seventy-three cents (\$41.73) unexpended.

Report of the Superintendent of Schools.

HOLDEN, MASSACHUSETTS,
January 1, 1915.

To the School Committee of the Town of Paxton:

I take pleasure in submitting my second annual report as superintendent of your schools.

During the summer there was a complete change in our teaching force. This made it especially difficult for the new teachers this fall, but they have taken a great interest in their work and made a good start. To avoid the difficulties experienced last year of having teachers leave on short notice in the midst of the term, we have engaged all of our teachers this year in accordance with the principles set forth in the report of last year. We are greatly handicapped in securing teachers by two factors: the first is the low salary offered; the second is the extreme difficulty of securing boarding places for the teachers. It is very discouraging for a new teacher, a stranger in our midst, to find that she is not welcomed anywhere. Unless this difficulty can be remedied, Paxton will soon find that the teachers will all insist on living in Worcester and traveling back and forth daily. This will prove a decided disadvantage, especially during the winter. With regard to salaries, one Normal School principal wrote: "Two thirds of the young ladies of the graduating class of 1914 have secured positions at salaries of \$11 or \$12 a week; a \$10 rate is the exception. Several are receiving as high as \$500 a year or more." Many of the promising candidates are refusing to consider positions at salaries of \$10 a week, from which \$35 a year must be deducted for the Teachers' Retirement Association, and \$5 or \$6 a week for board.

There have been few changes in the school work this year. The girls continue to have sewing and cooking, while the boys have elementary science and manual training or drawing. We have a supervisor of music again this fall, and under her supervision the pupils are making good progress in their music. In the grammar school, a club has been formed. At the fortnightly meetings the pupils are learning to stand on their feet and discuss questions, how to conduct a meeting, and some of the elements of parliamentary law. In the spring we hope to give the parents an opportunity to see the results of these special lines of work.

I hope some of the pupils will enter the State contests in sewing, cooking, and farming this year. Clubs were formed last year in Holden and Oakham and a Holden girl won third prize in cooking, and an Oakham boy won third prize on potatoes, raising 47 bushels of excellent potatoes on an eighth of an acre of land. The first prize is a trip to Washington, the second, a trip to points of interest in New England, and the third, a week at M. A. C. With the co-operation of the homes and the grange we ought to be able to interest several of our boys and girls in this valuable work.

The painting of the schoolhouse and the purchase of new curtains have greatly improved the appearance of the building. The interior should be varnished this year. The boys, as a part of their work in manual training, have painted the blackboards. In the spring, I hope to have them improve the grounds by setting out some shrubbery. The Agricultural College and the Worcester Normal School are ready to help us in this type of improvement. If the floors were oiled three times a year there would be much less dust in the air in the school.

During the year a number of worn out sets of books have been replaced. There is need of a new set of arithmetics, penmanship manuals, readers, and supplementary books on history and geography.

The Act of 1913 requiring Paxton to transport its pupils attending high schools in other towns has added a large item to our annual budget. We have been reimbursed for one-half of the

expense incurred last year, and will probably be reimbursed for a half each year.

I want to urge the parents to give the teachers their hearty co-operation and help. Whenever wild rumors are brought home by the children about their work, the parents should investigate for themselves before they believe the stories. The best teachers are often discouraged by idle gossip about school affairs. If we are to secure the best results there must be cordial team-play between the home and the school.

In order that we may carry on the work of next year successfully we ought to receive an increased appropriation. It is costing \$54 a year more for the transportation of the elementary pupils. We ought to increase the salaries of our successful teachers enough to retain them for another year. At least \$50 ought to be spent on new textbooks if we are to get the best results. Paxton is spending a little over \$4 per \$1,000 of valuation. In the latest report of the State Board of Education it is stated that the average amount spent from the proceeds of local taxation for each child in the average membership of the public schools was \$37.64 for all the State and \$22.87 for Paxton.

I want to thank the committee for their co-operation and assistance and the teachers for their faithful devotion to their work.

To either of the Constables of the Town of Paxton in the County of Worcester.

GREETING:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of the Town of Paxton, qualified to vote in elections and town affairs, to meet in Allen Hall in said Paxton on Monday, the first day of March next, at 9 o'clock in the forenoon, then and there to act on the following articles, namely:

Article 1. To choose a moderator by ballot to preside at said meeting.

Article 2. To hear the reports of the Town Officers and Committees and act thereon.

Article 3. To bring in and deposit their ballots for Town Clerk, three Selectmen, three Overseers of the Poor, Town Treasurer, Collector of Taxes, Auditor, Superintendent of Streets, two Constables, and three members of the Board of Health, each for the term of one year; one Assessor for three years, and one Assessor for two years, to fill vacancy, one member of the School Committee for three years, and two Trustees of the Public Library for three years. All the above to be voted for on one ballot; also upon the same ballot to vote "Yes" or "No" on the question:—"Shall license be granted for the sale of intoxicating liquors in this town?"

Also upon the same ballot to vote "Yes" or "No" upon the question "Shall chapter 352 of the Acts of 1914 being an act relative to pensioning laborers in the employ of fire and water districts, be accepted by this town?"

Also to choose all other necessary Town Officers for the year ensuing.

The polls will be opened at 11 o'clock A. M. and may be closed at 3 o'clock P. M.

Article 4. To raise and appropriate such sums of money as may be deemed necessary for the support of the Town's Poor, repairs of Highways and Bridges, for the support of the Public Schools, and transportation of pupils, breaking out roads, for fire purposes, and for contingent expenses for the ensuing year.

Article 5. To see if the town will grant and appropriate a sum of money for Memorial day, and for the relief of indigent and disabled soldiers.

Article 6. To see what disposition the town will make of its Dog Fund.

Article 8. To see if the town will grant a sum of money with which to pay a proper charge of a Surety Company for acting as surety on official bonds required by town officers and authorize the Selectmen to approve the same, or act in any way thereon.

Article 8. To see if the town will vote a discount on taxes paid before a given date and fix a time when interest shall be charged and taxes made payable, and likewise fix the compensation to be paid the Collector for the ensuing year, or take any action in relation thereto.

Article 9. To see if the town will authorize the Town Treasurer by and with the approval of the Selectmen, to borrow money from time to time in anticipation of revenue of the present municipal year beginning January 1, 1915, to an amount not exceeding in the aggregate, three thousand dollars (\$3,000) and to issue a note

or notes therefor payable within one year, or act any way thereon.

Article 10. To see if the town will vote to accept the list of Jurors as prepared and posted by the Selectmen.

Article 11. To see if the town will vote to raise the sum of ten dollars (\$10) and appropriate as much of it as may be necessary to carry out the provisions of Chapter 502, Acts of 1906, relating to the appointment of School Physicians.

Article 12. To see if the town will fix the compensation for labor on the highways the ensuing year.

Article 13. To see what action the town will take regarding the care and rental of the town hall, and also care of the town clock the ensuing year.

Article 14. To see if the town will grant a sum of money to be used to suppress the gypsy and brown tail moths in this town.

Article 15. To see if the town will grant a sum of money to be expended in the care and improvement of the Common, or act in any way thereon.

Article 16. To see if the town will grant a sum of money to be expended by the Tree Warden the ensuing year.

Article 17. To see if the town will vote to grant, under certain conditions, a sum of money with which to resurface the Barre road where needed and to build the road to the Rutland line.

Article 18. To see if the town will vote to raise and appropriate a sum of money to be used in the celebration of the 150th anniversary, or act in any way thereon.

Article 19. To see if the town will vote to appoint a Trustee for the Charles D. Boynton Fund in place of Walter E. Clark, resigned, or act in any way thereon.

Article 20. To see if the town will vote to sell a piece of land at the corner of the Barre and Brigham Hill roads, or act in any way thereon.

Article 21. To see what action the town will take regarding shed situated next to Record Building and owned by the town.

Article 22. To see if the town will vote to authorize the painting of the interior of the School House, grant and appropriate a sum of money therefor, or act in any way thereon.

Article 23. To see if the town will vote to raise and appropriate a sum of money to pay for the transportation of High School pupils.

Article 24. To see what action the town will take, if any, in procuring bids for the transportation of all pupils to the town and Worcester high schools.

Article 25. To see if the town will vote to accept the sum of two hundred dollars (\$200) as left by the will of the late Persis G. Boynton, the income only to be used for the perpetual care of the burial lots of John and Lucretia Warren and also that of David F. and Persis G. Boynton in Paxton cemetery.

Article 26. To see if the town will vote to elect a Board of Water Commissioners, as provided in Chapter 361, Acts of 1912, one for one year, one for two years, and one for three years, and every year thereafter to elect one for three years.

Article 27. To see if the town will instruct the Overseers of the Poor to contract with the Charlton Poor Farm Association for the support of the town's poor for a term of five years from January 1, 1915.

Article 28. To see if the town will accept Sections 21-22-23-24 and 25 of Chapter 78 of the Revised Laws of the Commonwealth and elect by ballot a Board of Cemetery Commissioners, one for one year, one for two years, and one for three years, and each year thereafter to elect one for three years, or act in any way thereon.

And you are hereby directed to serve this Warrant by posting attested copies thereof, one at the Post Office and one at the Blacksmith Shop in said town of Paxton, ten days at least, before the time set for holding said meeting.

Hereof fail not, and make due return of this Warrant with your doings thereon to the Town Clerk at the time and place of meeting aforesaid.
