I submit herewith my report of an audit of the books and accounts of the town of Paxton for the period from May 8, 1941 to April 12, 1942, made in accordance with the provisions of Chapter 44, General Laws. This is in the form of a report made to me by Mr. Herman B. Dine, Assistant Director of Accounts.

Sir:

In accordance with your instructions, I have made an audit of the books and accounts of the town of Paxton for the period from May 8, 1941, the date of the previous audit, to April 12, 1942, and report thereon as follows:

The records of financial transactions of the several departments receiving or disbursing money for the town, or committing bills for collection, were examined, checked and verified by comparison with the reports and the records in the town accountant's office.

The accountant's ledger was analyzed, the appropriation accounts being checked to the town meeting records of appropriations and transfers voted. A balance sheet, showing the

financial condition of the town on April 12, 1942, was prepared and is appended to this report.

The books and accounts of the town treasurer were examined and checked. The recorded receipts were analyzed and compared with the accountant's ledger and with the records of the departments making payments to the treasurer, while the payments by the treasurer were checked with the selectmen's warrants authorizing the disbursement of town funds.

The payments of maturing debt and interest were verified by comparison with the amounts falling due and with the cancelled securities on file.

The savings bank books representing the investments of the several trust funds in custody of the town treasurer were examined and listed, the income being proved and the withdrawals verified.

The tax title deeds on hand were listed and the amounts transferred to the tax title account were verified.

The surety bonds of the officials required by law to furnish them were examined and found to be in proper form.

The books and accounts of the tax collector were examined and checked. The commitments of taxes were compared with the warrants issued by the assessors, the recorded abatements were checked with the assessors' records of abatements granted, the recorded collections were checked with the payments to the treasurer as recorded on the treasurer's and the accountant's books, and the outstanding accounts were listed and proved with the controlling accounts.

The outstanding accounts were verified by sending notices to a number of persons whose names appeared on the books as owing money to the town, and from the replies received it appears that the accounts, as listed, are correct.

The record of licenses issued by the selectmen and town

clerk were examined and checked, and the payments to the State and the town were verified.

The charges for the rentals of municipal buildings were examined and verified, the recorded receipts being proved with the payments to the treasurer.

The books and accounts of the municipal light and water departments were examined and checked. The charges were totaled and the recorded collections were compared with the records in the treasurer's office, the abatements as recorded were checked with the records of the commissioners, the cash on hand was verified by actual count, and the outstanding accounts were listed and proved.

In addition to the departments mentioned, the books and accounts of the sealer of weights and measures and of the public welfare and cemetery departments were examined and checked, and the payments to the treasurer were verified.

For the cooperation extended by the several town officials during the process of the audit, I wish, on behalf of my assistants and for myself, to express appreciation.

To the Voters of the Town of Paxton:

A report of the Planning Board pertaining to Article 35 of the 1942 Town Warrant:

The Board has made a survey of two parcels of Town owned forest land, namely that which is located and bordering the Holden Town line and starting at a point at the junction of the Paxton and Holden Town line and running in a north-westerly direction, and thence to a point 250 feet from the water line of Asnebumskit Pond, and following the contour of the Pond to and bordering the Holden Road to a point west of the Road leading to the Reservoir, and bordering A. E. Thompson land. This parcel has an area of approximately 40 acres. About 60% of this area could be re-forested, the remainder being swamp land. Any project of re-forestation would require extensive preliminary work in the form of clearing hurricane timber and brush. Available Town help could be

used for the clearing. In referring to this report we will call this Parcel 1.

Parcel 2 consists of land known as the Illig property, same starting at a point at the rear of the School and running easterly to and bordering the rear of lot lines on Pleasant Street, then extending in a westerly direction and bordering the land of George Clapp and Samuel Clapp; then in a northerly direction by land of G. A. Rossier to a point of beginning, including Mathews Pond. This area contains 45 acres, of which about 34 acres are suitable for re-forestation, with less preliminary work than Parcel 1.

The Howe Farm was not considered, as it would lose its value as a farm if re-forested.

## REPORT OF THE

## SUPERINTENDENT OF SCHOOLS

Holden, Mass., Dec. 31, 1942

To the School Committee of Paxton:

This report is the forty-third in the series since the formation of the present Union, and the twenty-fifth by the writer.

Although there have been frequent interruptions of our regular school work I believe it has been carried on successfully, and our special thanks and appreciation are extended to the teachers for their wholehearted response to the many calls for "extra-curricular" service in connection with registration and rationing programs. In all this special work we had the splendid cooperation of the local Ration Board. There will be other demands upon the time of the schools, and sacrifices to be made, but we shall meet them and do our part in the "all-out" for victory, without losing sight of the responsibility that is ours for training the coming generation in the ways of true democracy and the means of preserving it.

Sugar rationing involved the registration of every family with all its members. This was followed by two gasoline or "mileage" registrations, one for an emergency temporary program and one for a permanent program. More recently there was fuel oil rationing, work for the Junior Red Cross, sales of seed for "V" gardens and sales of War Savings Stamps. In this work and in the collecting of rubber, of keys and of scrap, the children responded with enthusiasm. Sales of Stamps for the last three months were \$510.10 with about half of the entire school participating. At the Annual Teachers' Convention in Worcester, Governor Saltonstall said "The work of you

teachers in this time of crisis has been tremendous; you have contributed to the war effort, and as Governor of this State I want to thank you for your work."

There have been two changes in the teaching force, and Dr. Mayo, the School Physician, resigned in October to enter government service. There is a serious and increasing scarcity of teachers. This fact and the increasing cost of living have already upset salary schedules, and we must expect this condition to continue for some time. Fortunately we were able to meet the situation and Mr. Hurlburt S. Trecartin was secured to succeed Mr. Johnson who resigned to go to Connecticut. Mrs. Phyllis Deignan of Worcester was appointed for Grades V and VI to take the place of Miss Bancroft who resigned.

The school property is in excellent condition, and thanks to the foresight of the Committee, we are well supplied at the present time with books and equipment. Enrollment in the grades has dropped, but our registration is about the same as last year, there being more pupils attending schools in Worcester. There were 16 in the graduating class last June and we have but 6 in the present eighth grade.

Junior First Aid Certificates were presented at graduation to William Brady, Edward Bigwood and Kathleen Brady. The American Legion awards were presented to William McKinley and Carol Sheehan. First prizes in the Poster Contest went to Barbara Dixon and Jean White; second prizes to Russell Abbott and Carol Sheehan; honorable mention, William Ahearn, Alden Abbott, Donald Flint and Norma Perkins.

Acknowledgment with sincere thanks are extended to Mrs. George Hunt for gifts of books and toys to Grades I and II, and to the American Legion Auxiliary for a book case for Grades V and VI. Special mention should be made of the generous gift from the Sons of Paxton of a War Savings Booklet containing 50¢ in Stamps to each pupil of the School. It was

reported in June that over \$500 had been invested as the result of this special incentive to saving and furthering the war effort.

The reports of the Supervisors, School Nurse and School Physician are of particular interest and value in showing the varied activities of the school. The suggestions of the School Nurse carry special weight in view of the absence of Dr. Mayo and the necessity for full cooperation between parents and the school in maintaining good health of the pupils.

I want to thank the Committee, parents and teachers for their fine cooperation during the past year.

## **MUSIC SUPERVISOR**

To the Superintendent of Schools:

It is with pleasure I submit the following report of the progress in the Music Department.

At the present time the general heading Music includes the following: singing, eurhythmics, rhythm bands, sight reading, theory, and appreciation. To develop a love for and appreciation of good music through participation we place special emphasis on overcoming monotones and finding the child's singing voice in the first two grades. In the third and fourth grades stress is placed on developing independent singing and ability to read music. Part singing is begun in the fifth and sixth grades and continued in the seventh and eighth grades with the lowest part being written in the bass clef.

Suspension of school during the rationing periods prevented any observance of Music Week, but music played no small part in the graduation exercises.

During December assemblies were held for carol singing and it is my intention to hold these assembly "Sings" each month. Today, more than ever Music is a necessity. The English Government "recommends music for children as a measure of education and self-expression. Music is helping Britain maintain her morale to win the war."

"On wings of song let us help to defend and preserve, for ourselves and our posterity, the ideals and practices of our beloved American democracy."

I wish to thank you, the School Committee, the teachers and the pupils for the interest, assistance and cooperation given this year.

## REPORT OF THE

## SCHOOL PHYSICIAN

To the Superintendent of Schools:

The following is my report as School Physician in this Union during the past year.

In the Spring of 1942 the vaccination clinics and the examinations of pre-school children were held in each school throughout the district. At the same time the school buildings were inspected for sanitation. Diphtheria clinics were held in Rutland by the State Board of Health, and in Holden they were conducted by Dr. Crane and myself under the auspices of the local Board of Health. In October the children were examined in each school of the district, and the buildings were again inspected. The children seem to be in unusually good health this Fall, and we have been fortunate in not having any major epidemics of contagious diseases.

# PRE-SCHOOL WELL CHILD HEALTH CONFERENCE

To the Board of Health, Paxton, Mass.

I wish to report that the Well Child Conference was held on September 28, 1942.

Twenty-five children came to the clinic. Dr. Thomas P. Cunningham was the Pediatrician. Dr. Bessie Scott served as our Dentist and Miss Sophie Gordon of the State Department of Public Health was the nutritionist. Mrs. E. Crossley Butler, the school Nurse, did the follow-up work for the Clinic.

I might stress how satisfying it is to find on the check-up visits that most of the suggestions received at the Clinic have been followed out by the various Mothers with good results.

Quite a number of children were found to need dental care and it was advised that several children should have more frequent medical attention.

A number of children for whom appointments were made developed colds at the time of the Clinic. However, Mrs. Butler called on those who had visited the Clinic in previous years.

I feel that the Conference is a very valuable service to the good health of our children, and sincerely hope it may be continued as a regular thing.

# REPORT OF THE

## DRAWING SUPERVISOR

To the Superintendent of Schools:

The work in the Art Department this year has covered the care and use of materials, and the subjects of representation, design, space and tone relation, lettering, construction and handcraft, modeling in clay, and art appreciation. Through correlation and efficient cooperation art work becomes "a helping hand, a kind of connecting link that binds all other subjects to it, and makes every study at school more interesting and valuable because we are building for the future as well as for today."

From our foundation program of last year a working and graded outline has been established. A general library of pictures has been started for the Union. By means of Kodachrome slides lessons in art appreciation have been given; appreciation of the things about us in everyday life for the lower grades, and in upper grades a study of the types of art, drawing, painting, color, sculpture, architecture and the crafts.

We have made use of available waste material in our program, posters in the War Effort have been designed, and projects are under way that include the making of maps, charts and various models in housing, etc. Mr. Reynolds, the State Director of Art Education in Massachusetts addressed the teachers of the Union on "Art and the War Today."

In closing I wish to extend my sincere appreciation for your interest and assistance, and to thank the teachers and pupils for their splendid cooperation.

## SCHOOL NURSE

To the Superintendent of Schools:

At the close of the school year the annual routine clinics and examinations show the following results.

- 1. Pre-school vaccination and examination clinic—9 attended.
- 2. Tonsil clinic—2 attended.
- 3. Dental clinic-41% attended.
- 4. Annual physical examinations—no major defects found.
- 5. Monthly sanitary inspections—special reports submitted.
- 6. Weighing and measuring—3 times during year—all gaining normally.
- 7. Transfer of 8 children from pre-school well-child clinic with all minor defects corrected.
- 8. Home calls and conferences—26.
- 9. Visual and auditory defects—4 cases—3 cases receiving maximum treatment.

With the entrance of Dr. Mayo into the armed forces, we feel it vitally important that the home and school continue to cooperate to maintain the health standards achieved during the past year.

A few suggestions are offered the parents.

- 1. Do not send a sick child to school.
- 2. Do not send a child to school who has been in pain, or who was nauseated the previous night.
- 3. Remember watery eyes and noses are often fore-runners of a communicable disease.
- 4. Protect other members of your family by promptly isolating the sick child.
- 5. Do not hesitate to call your family physician if in doubt.

- 6. Provide simple, nourishing, well-balanced meals for your child.
- 7. See that your child is adequately dressed for the weather.
- Remember colds are readily checked if prompt treatment is begun—bed rest, forced liquids and isolation are important.
- 9. Transportation of a sick child to his home constitutes a serious problem. Be prepared to do your part.
- 10. Your child's teacher is interested in the health of her entire classroom. Notify the teacher of your child's absence. The teacher will be watchful of like symptoms in other children.
- 11. Send an explanatory note to the teacher following absence. Determination of a child's fitness to participate in a full day's routine can then be made.
- 12. Secure from your family physician or local Board of Health the necessary certificate for the child to return to school following a communicable disease. No child will be admitted without this certificate.

The health of the child is important. We will do our part. Will you?

To the teachers, the janitor and all who have made the health program pleasant and effective, I wish to express my sincere appreciation.

## TREE WARDEN

In this department, very little has been done during the past year as the events at Pearl Harbor made one feel that the expenditure of money for anything but absolute necessities was unpatriotic, and while plenty of repair work and the setting of a few trees might have been done, the writer is glad to report the major part of his appropriation unspent.

The recent ice storm has of course increased the need of work and replacement, yet in the face of war's demands which *must* be met, the above mentioned needs can be temporarily sacrificed. The following suggestion might to some extent take care of things at no expense.

A practise being followed in some towns and being urged for adoption by the Mass. Forest and Park Association, is the cutting down of dead trees, the thinning out of others, and the trimming of broken branches by residents living nearest the places where such conditions exist, for the purpose of adding to the worker's fuel supply and the improvement of the town's roadsides. Such work would need to be done under individual permits. I trust the Board of Selectmen will sanction this action.

## TOWN WARRANT

## THE COMMONWEALTH OF MASSACHUSETTS Worcester, ss.

To the Town Clerk of the Town of Paxton,

GREETING:

In the name of the Commonwealth you are hereby directed to notify and warn the inhabitants of said Town, who are qualified to vote in elections and in town affairs, to meet in "Allen Hall" on Monday, the First day of February 1943, at 12 o'clock, Noon, then and there to act on the following articles, namely:

Article 1. To bring in to the Election Officers their votes for the following town officers to be voted for on the official ballot:

Moderator, Town Clerk, Collector of Taxes, Town Treasurer, two Constables and Tree Warden all for the term of one year; also one member of the Board of Selectmen for 3 years; one member of the Board of Selectmen for one year to fill vacancy, one member of the Board of Public Welfare for three years, one member of the Board of Assessors for three years, one member of the School Committee for three years, one member of the Municipal Light Board for three years, one Cemetery Commissioner for three years, one Water Commissioner for three years, two Trustees of the Richards Memorial Library for three years, and one member of the Planning Board for five years.

All of the above officers to be voted for upon one ballot.

Also to choose any other necessary town officers for the ensuing year.

The Polls will be open from Noon until 8 o'clock P. M. Business meeting at 7 o'clock P. M.

- Article 2. To hear the reports of the town officers and committees and act thereon and to act upon any recommendations contained in said reports, and to raise and appropriate such sums of money as may be required in accordance with said reports, or otherwise, or act in any way thereon.
- Article 3. To see if the town will raise and appropriate a sum of money (see budget) with which to pay the proper charge of a Surety Company for acting as surety on bonds required by town officers and authorize the Selectmen to approve the same.
- Article 4. To see if the town will authorize the Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1943, and to issue a note or notes therefor payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44 of the General Laws.
- Article 5. To see if the town will vote to raise and appropriate the sum of \$180.00 for the construction of sidewalks, together with the income of the C. D. Boynton Fund for General Purposes for 1942 and 1943, or act in any way thereon.
- Article 6. To see if the town will vote to raise and appropriate the sum of \$900.00 to be used on Chapter 90 roads for Maintenance, said money to be used in conjunction with any money which may be allotted by the State or County, or both, for said purpose or act in any way thereon.
- Article 7. To see if the town will vote to raise and appropriate the sum of \$50.00 for a Well Child Health Conference for Pre-school children and follow-up work connected therewith, or act in any way thereon.

- Article 8. To see if the town will vote to raise and appropriate the sum of \$500.00 to purchase an Honor Roll, same to contain the names of Paxton men who have gone to war, or act in any way thereon.
- Article 9. To see if the town will vote to raise and appropriate the sum of \$1,000.00 to repair and trim trees along the highways which were damaged by the ice storm of December 1942, or act in any way thereon.
- Article 10. To see if the town will vote to raise and appropriate the sum of \$350.00 to paint the Town Hall, or act in any way thereon.
- Article 11. To see if the town will vote to give the fire Department members compensation for their services, or act in any way thereon.
- Article 12. To see if the town will vote to pay the Moderator \$10.00 for his services at the Annual Town Meeting and \$5.00 for any Special meetings, charging the same to Contingent, or act in any way thereon.
- Article 13. To see if the town will vote to transfer the sum of \$308.00 from the Highway Equipment Fund to the Highway Equipment Maintenance Fund to be used to furnish supplies and maintain the Town's highway equipment, or act in any way thereon.
- Article 14. To see if the town will vote to transfer the sum of \$1,000.00 from Surplus to the Reserve Fund, or act in any way thereon.
- Article 15. To see if the town will vote to appropriate the money received from the Dog Fund to the Richards Memorial Library, or act in any way thereon.
- Article 16. To see if the town vote to raise and appropriate the sum of \$50.00 for patrol of forest fire areas under the supervision of the director of the Division of Forestry with

the co-operation of the local Forest Fire Warden, as recommended in the Forest Fire Patrol law enacted October 24, 1941, or act in any way thereon.

Article 17. To see if the town will vote to authorize the Assessors to use up to 60% of the surplus funds in the hands of the Town Treasurer, available when the tax rate is ready to be set, as recommended by the Tax Commissioner for the purpose of reducing the tax rate for the current year, or act in any way thereon.

Article 18. To hear the report of the Town Treasurer in regard to the disposal of certain properties acquired by Tax Titles, and act thereon.

Article 19. To see if the town will vote to appoint the American Legion as a committee to have charge of the observance of Memorial Day, or act in any way thereon.

Article 20. To see if the town will vote to appoint a committee to have charge of the Fourth of July, or act in any way thereon.

Article 21. To see if the town will vote to authorize the Selectmen to loan the chairs from the Town Hall to Town Organizations and private responsible parties, or act in any way thereon.

Article 22. To see that there be included in the tax levy for electricity used for street lights the sum of \$500.00 and that said sum and the income from sales of electricity to private consumers or for electricity supplied to municipal buildings or for municipal power and for sales of appliances and jobbing during the current fiscal year, be appropriated for the Municipal Light Plant, the whole to be expended by the manager of the Municipal Light Plant, under the direction and control of the Municipal Light Board for the expense of the plant for the said fiscal year, as defined in Section 57, Chapter 164 of the

General Laws and Chapter 235 of the Acts of 1937, and that if said sum and said income shall exceed said expense for said fiscal year, such excess shall be transferred to the construction fund of said plant and appropriated and used for such additions thereto as may thereafter be authorized by the Municipal Light Board.

Article 23. To see if the town will vote to hear the report of the Planning Board, which is also printed in the Town Report, as voted under Article 35 of the warrant for the 1942 Town Meeting, or act in any way thereon.

Article 24. To see what suggestions or recommendations the town wishes to make regarding Bus service.

And you are directed to serve this warrant by posting two attested copies thereof, one of which shall be at the Post Office, seven days at least before the time set for holding said meeting as directed by by-law.

Hereof fail not and make due return of this warrant, with your doings thereon, at the time and place of meeting aforesaid.
