School Caucus - November 22, 2005

- Discussed the meeting that took place and the equalities of the formula for payments to the schools.
- (FG) suggested that (MQ) be the representative for the BOS on the Regional Committee headed by Joe Sullivan of Holden.

School Building Tour November 30, 2005

- (CB) and (FG) toured the new buildings under construction and commented that they moving along, but did not see \$75 million of building.
- Meeting with Roger Hatch to discuss School Budget December 12, 2005 at Central Tree School

<u>Appointment</u>

• Motion (JM) seconded (FG) to appoint Mary Kate Gainty to the Cultural Council. Unanimous.

American Legion 304

- (CB) reviewed at the BOS request as to whether money could be expended by the Town to help with the drainage problems at the Legion. MGL C40 §9 states that money can only be appropriated for veteran's organizations for the leasing of space and for celebration of holidays.
- (FG) had visited the property and none of the water that he saw was due to either work by the state or new construction. Town cannot contribute for the cost of rectifying the drainage problem.

Fire Safety act MGL 148

- (CB) do not have too many facilities that would need to enact this law.
- Motion (FG) seconded (JM) to not enact this law. Unanimous.

Town Administrator Update

Technical Assistance Program

- (CB) Memo to BOS regarding assistance available from the Division of Local Services.
- **Motion** (FG) seconded (JM) to send a letter to the DLS requesting a financial management review of the financial operations and conditions of the Town. (MQ) recused himself as a DOR employee.

Performance Reviews

• (CB) will be conducting performance reviews on employees who report to him.

Lincoln Environmental

• (CB) looked into the oil spill taken care by Lincoln Environmental at 19 Forestdale. Apparently site is clean, DEP will send final report.

Technical Assistant Grant

• (CB) Contract signed and received, need to recruit members for the Stormwater Management and Open Space Bylaws.

Wheelabrator

• (CB) revised proposal from Wheelabrator sent on to the BOH.

Local Emergency Preparedness

- LEP Grant of \$12,000 received for a new generator, apparently a new generator will cost \$20,000 not \$8,500 as expected.
- Discussed and it was determined that this item should go before the Capital Improvement Committee on December 14, 2005, BOS would like further information and if BOS agree will need a STM vote to appropriate further amount for the generator.

Town Hall Renovation

• (CB) received estimates from architectural firms on the cost of performing an assessment of the Town Hall physical condition; this would be not more than \$5,000.

Special Town Meeting

(CB) requested a STM in early 2006 to consider funding for Town Hall Physical Condition
Evaluation, Site Evaluation for Police and Fire Facilities, Master Plan Funding, Additional funding
for a emergency generator, vote on establishment of South Paxton Sewer District. This was
discussed and BOS agreed to a meeting February or March 2006.

Highway Department

- (CB) DPW Superintendent has completed his evaluation of Gary Richards as Highway Department Working Foreman and both he and (CB) and recommend that his probationary period be considered complete and bring his pay rate to \$17.56.
- Motion (JM) seconded (FG) to accept the recommendation. Unanimous.

Other Business

15 West Street

- (CB) Disclosure of uniqueness and financial disclosure and then wait 30 days before final offer.
- Motion (MQ) seconded (JM) relative to the proposed acquisition of real property known as and located at 15 West Street, Paxton, MA, Assessor's Parcel Number Map 18 Lots 3 & 4 (the "Property"), the Board determine that advertising in accordance with the requirements of Section 16 of Chapter 30B of the general laws will not benefit the Town's interest because of the following unique qualities and location of the Property:
- The Property is located adjacent to and between two Town-owned properties, the Paxton Center School and the John Bauer Senior Center municipal building, and, therefore, the Property presents a unique opportunity to acquire land that will enable any future expansion of the school or the municipal building and will also provide adequate land area for the location of any accessory use that the Town may deem necessary. Unanimous.
