Regular Meeting Minutes

The Chairman called the meeting to order at 7:00pm.

The Chairman announced that due to the lack of heat in the building we will have the Classification Hearing and then we will reschedule the remainder of the meeting until Thursday, November 8, 2012.

Classification Hearing

- Kathleen Stanley presented the Board of Selectmen with the annual Classification Hearing. It is the responsibility of the Board of Selectmen to vote on four items.
- The first item to be voted on, is in order to set the tax rate the Board of Selectmen have to vote on either a Factor 1 or Formula 797 calculation. <u>Motion (JM)</u> <u>seconded (FG) to accept Factor 1 and set a single tax rate of \$19.22 for FY13.</u> <u>Unanimous, all in favor.</u>
- The second item to vote on is whether or not to give a discount for open space. . <u>Motion (JM) seconded (FG) to not give a discount for open space.</u> <u>Unanimous, all in favor.</u>
- Item number three is whether or not to provide a residential exemption. <u>Motion</u> (JM) seconded (FG) to not give a residential exemption. Unanimous, all in <u>favor.</u>
- Item number four is whether or not to provide a small commercial exemption. <u>Motion (JM) seconded (FG) to not give a commercial exemption, and open</u> <u>for discussion.</u>
- (FG) Part of our Master Plan is to encourage small businesses in Paxton, and I feel that a 10% reduction would be worth it.
- Kathleen Stanley stated that it is too late to do that for this year, but is something that we could look at for next year.

- (FG) That is something that I would like to look at for next year.
- Motion approved. Unanimous, all in favor.
