Regular Meeting Minutes

The Chairman called the meeting to order at 7:00pm.

15 Orchard Drive

- Deirdre Malone presented the Board with a question concerning the property at 15 Orchard Drive. The owner of the property has passed away and the property is in tax taking. We can either bundle it with some of our other receivables, or it could be placed in land court.
- **(PB)** What would you recommend?
- Deirdre Malone replied that the attorney that she spoke to in regards to this recommended that we bundle it with some of our other receivables.
- (JP) I understand that Medicare also has a lien on this property?
- Deirdre Malone replied that the Medicare lien was with the parents and not sure if it carries onto the children.
- (JP) If there is a large Medicare lien then we may not get anything off of it anyways.
- **(PB)** Do we know what condition the property is in?
- Deirdre Malone replied that we are unsure because no one has been in it but have heard that it is in bad shape.
- (CR) We are not in this to make a profit. We just want to get payment on the lien.
- (JM) We have done well with selling off receivables so I feel that we should start that way.
- (PB) I agree. I think that we should do what we know and stick with selling off the receivables.
- Motion (JM) seconded (JP) agree to sell off the receivables rather than trying to sell the property outright. Unanimous, all in favor.

• (CR) We need at least 50 voters in order to hold the Special Town Meeting.

Town Administrators Update

• Fire Dept.

The hot and dry temperatures have led to brush fires around the Pine Hill Reservoir. This has caused our Fire Dept. to be extremely busy this month.

• New Public Information Request Law

I provided under separate cover information regarding the New Public Information Request Law that comes into effect on January 1, 2017. The provisions of this law will be burdensome for towns, with additional recording and compliance. We are actually experiencing more public information requests relating to payroll and purchases. (CR) We will need to designate a Public Information Officer when the time gets closer.

• Real Estate Taxes

Preliminary half yearly taxes have been issued and are due October 1st. Residents who have not received a bill should contact the tax collector. Bills are sent to the property owner on file as of January 1st of the year.
