Both of our school committee members voted in favor of the school budget so hopefully they will be at the meeting to support it. We as a unit have said that we would not support an override, yet we just approved an override for the road resurfacing.
- (JM) We have to do something for our infrastructure, and if we don't set this money aside we will never have it.
- **(PB)** I understand I just want to make sure we can explain why we are in favor of an override when that has not been our stance in the past.

Town Administrator Update

• FY16 Budget

At time I don't see any problems with the current budget that have not been addressed. The Snow & Ice budget took an unexpected hit with the April snow storms. (Balance will be provided at the meeting after 4/8 and 4/11 warrants prepared).

(CR) we currently have \$5,000 left in snow and ice and \$18,000 left in compensation.

• DPW

Mike Putnam, DPW Superintendent recently took the initiative to register himself and his department for hoisting training through the free program offered by MIIA. The six training courses can generally cost \$95 to \$150 each; so the fact that Mike searched out these MIIA offerings saved the Town money. The Police Dept. took a similar approach last year with the Safe Driver training.

• Audit

The FY15 Audit has been completed by Roselli, Clarke & Associates. Electronic copies have been distributed. The Management Letter did make mention of seven items that we have accomplished that were brought up in the previous year's audit.

Does the Board wish to request an exit interview with the Auditor as we did in last year? The Board agreed that an exit interview was not necessary.

• Data Security Audit

The Data Security Audit will be completed within the next week or two; we will need to discuss the reports in executive session at a later date. As part of the grant process we will have eighteen new procedural policies reviewed and put in place.

• Baypath Voc. School

Recently over 40 seniors took a tour of Baypath Vocational School's new renovations and got to have lunch is the attractive cafeteria. I want to thank John Lafleche and Robert Wilby for arranging this visit for our seniors.

• Paxton Lions

Motion (JM) seconded (JP) to approve the use of the Town common and placement of signs for the Paxton Lions Town wide yard sale. Unanimous, all in favor.
