Regular Meeting Minutes

Monday, December 5, 2016

The Chairman called the meeting to order at 7:00pm.

We will enter into Executive Session and will only be returning to the regular meeting for the purpose of adjourning.

Classification Hearing

Kathleen Stanley, Administrative Assessor along with Joanne Savignac and Doris Huard from the Board of Assessors were present for the Annual Classification Hearing to set the tax rate for FY17.

- Motion (JM) seconded (JP) to approve the use of Factor 1 to calculate the tax rate. Unanimous, all in favor.
- Motion (JM) seconded (JP) that the Town will not provide a discount for Open Space. Unanimous, all in favor.
- Motion (JM) seconded (JP) that the Town will not provide a discount for Residential Exemptions. Unanimous, all in favor.
- Motion (JM) seconded (JP) that the Town will not provide a discount for Small Commercial Exemptions. Unanimous, all in favor.
- With these four items voted on a tax rate of \$20.39 was set.
- The Board signed the tax rate recap.

Mr. Grinstead's request to use Town Common

- Request to use the town common for the filming of a movie. This event is scheduled to take place on December 9th from 9am to about 2pm. All Public Safety Departments have been made aware of the request.
- Motion (JM) seconded (JP) to approve the request to use the Town Common provided all paperwork has been submitted. Unanimous, all in favor.

The Insurance Advisory Committee also suggested providing an opt-out for employees to take alternative health insurance than the Towns. I have received sample policies from other towns and I am asking the Board if you feel this is something that you would like me to pursue. If so I will put a policy together.

• MIIA Grant

I received notification that the grant I submitted for police dash cameras was successful and we have been awarded \$6,844 for two cameras.

• Salary Threshold Increase Ruling

Earlier in the year I informed you that the salary increases for overtime will increase in December. Apparently a federal court in Texas has issued a preliminary injunction blocking the implementation on the grounds that the Department of Labor exceeded its authority and lacked the power to implement these salary threshold changes. The change is therefore frozen at this time for all states.

• Trash Collection

There is an error on the recycling calendar. Trash and recycling will not be collected on the day after Christmas Day and New Year's Day. Collections will be Tuesday through Friday on those weeks.

• Richards Memorial Library

The Library will be having their annual Holiday party on Saturday, December 17th 3pm to 5pm with an opportunity for children to have their pictures taken with Santa.

Motion (JM) seconded (JP) to leave the regular meeting and entered into Executive Session at 7:30pm and we will only return to the regular meeting for the purpose of adjourning. Unanimous, all in favor.
