The Chairman called the meeting to order at 7:00pm.

Land Acquisition of 20 Briarcliff Lane

- Colin Novick with the Greater Worcester Land Trust is requesting the support of the Select Board to place a Conservation Restriction on a 67 acres parcel located at 20 Briarcliff Lane. The Greater Worcester Land Trust in conjunction with the Paxton Land Trust would like to see that this land is preserved. The parcel has a slope and wetlands so it would not be taking away any developable land from the Town. The parcel is in Chapter 61 already so there would not be a great loss in taxes for the Town. This is a prime forest soil area and feeds the drinking water.
- **(JP)** Who retains ownership of the land?
- Mr. Novick stated that the White Oak Land Conservation Society along with the current owners then it will be donated to the Worcester County Land Trust.
- (CR) How long until that takes place?
- Mr. Novick replied this will go to Boston next, so fairly quickly.
- Motion (JM) seconded (JP) to allow the Conservation Restriction on the 67 acre parcel located at 20 Briarcliff Lane, Paxton. Unanimous, all in favor.

• Recycling Grant

• Real Estate Taxes

The office will be opened on Friday, November 1st until 1pm for payments. There is also a drop box on the front of the building.

The last day for residents to register to vote at this meeting is November 8th. The Town Hall will be open until 8pm on that day for anyone in Town who is currently not registered to vote.
