### **Meeting Minutes**

 Motion (JM) second (DT) to accept the regular meeting minutes of May 17, 2011. Unanimous all in favor.

# **Capital Improvement Plan**

- Commissioners in receipt of draft CIP prepared by Tighe & Bond.
- Version 1 provided a full list of identified capital improvement needs at an anticipated cost of \$21,549,300 for full implementation and is not economically feasible using only the existing water rates. If these improvements were implemented over a 50 year period a 50% water rate increase would be required.
- The largest capital improvement item mentioned is the upgrading or replacement of two phases of 23,600 feet of unlined water mains at a cost of \$3.1 million
- Version 2 provided only urgent and critical need capital improvements at a cost of \$1,469,300 for full implementation and may be considered feasible using only water rate revenue.
- Due to the demographics of Paxton, there is little or no availability of grants to cover these necessary repairs.
- (MP) ongoing commitment to replace to water meters and a program to replace hydrants.
- Motion (JM) seconded (DT) to accept draft CIP and include funding of infrastructure discussion in future meetings. Unanimous all in favor.

### **Water Meters**

• (MP) provided information on meters that are networked and read remotely.

### **Account Balances**

• (MP) updated Water Commissioners on account balances, expected to need transfers within accounts.

### **Tank Repairs**

• Ongoing repairs, Maple Street tank will be repaired on June 28th.

### **AMC**

- Streeter Road valve configuration took place today. Water will be shut off on June 27th on campus to connect the main between Sunset Lane and Streeter Rd.
